Nominations are called for from Associations who are willing to host these Trials.

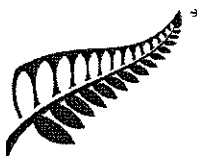
This event must be held on 4/5 February 2012.

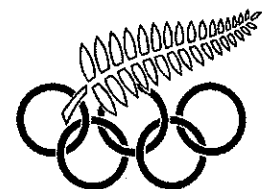


